FIRST AID

If Inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth to mouth if possible.

If in Eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses if present, after the first 5 minutes, then continue rinsing eye.

GENERAL INFORMATION

FLASH WETT enhances water infiltration, reduces channeling and preferential moisture flow through the soil profile, and increases the effectiveness of precipitation and irrigation. **FLASH WETT** improves nutrient availability and encourages stronger root development by increasing moisture penetration deeper into the soil profile.

When applied as directed, **FLASH WETT** permits water to enter the micropore space between soil particles without risk of excessive water retention and prevents water repellency from developing.

FLASH WETT effectively treats localized dry spot and compaction from traffic and highly managed turf programs. Perfect for injection systems and manual watering will be faster, more cost effective with regular use.

DIRECTIONS FOR USE

FLASH WETT will not burn plants when used as directed. Schedule application before precipitation or a regular irrigation session to move **FLASH WETT** into the soil faster.

For best results, inject or apply **FLASH WETT** at the rates shown below on a weekly basis before signs of stress appear.

APPLICATION RATES

Irrigation system injection -

Apply at a rate equivalent to 1.5 to 3 pints or 24 to 48 ounces per acre in pressurized irrigation systems.

Conventional spray system -

Apply at a rate equivalent to 1.5 to 3 pints or 24 to 48 ounces per acre.

Coordinate application with precipitation or regular irrigation cycle.

Transplant Shock -

Apply at 1.5 or 24 ounces per 1000 gallons of water to facilitate soil wetting while transplanting.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. Do not contaminate water, food or feed by storage or disposal of this product.

Disposal: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal if allowed by law. Decontaminated containers and materials must be disposed of in a manner allowed by local, state and federal laws and regulations.
