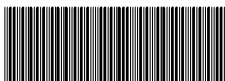

### GENERAL INFORMATION

**CONTROL™** spray drift mitigation and deposition aid is a very effective, easy-to-use adjuvant for improving on-target spray deposition, retention and lowering evaporation. **CONTROL™** reduces drift and improves efficacy at very low rates when applied by ground or air. **CONTROL™** mixes well with water and is compatible with most pesticides and other agricultural products.

### USE DIRECTIONS

1. Factors that influence the optimum rate of **CONTROL™** include spray mixture components, pressure, nozzle selection, application method, speed, pressure, nozzle type, and proximity to sensitive non-target areas. Use the higher recommended rates when applying at high application speeds and when mixing with chemicals that reduce spray droplet size.
2. If more drift reduction is needed, increase the rate of **CONTROL™** in 1 oz/100 gal increments until the desired effect is obtained. Reduce the rate if the spray pattern is distorted.
3. Do not use **CONTROL™** with Monsanto MAX® glyphosate formulations unless combined with 8.5 to 17 lb/100 gal of ammonium sulfate (AMS) or 1 qt/100 gal GarrCo **ASSIST™** compatibility agent. **CONTROL WM™** is compatible with Monsanto MAX® glyphosate formulations without AMS or **ASSIST™**.
4. May use in aquatic applications at labeled rates.

Use Rate Guidelines	
Application	Rate oz/100 gal
<b>Ground</b> Depending on nozzle, setup, and spray mixture Dicamba and 2,4-D mixtures	1 to 6 3 or higher
<b>Airplane</b> Depending on nozzle, setup, and spray mixture	1 to 8
<b>Helicopter</b> Depending on nozzle, setup, and spray mixture	0.5 to 4
